## **Vision & Purpose**

NPN envisions a world in which artists have greater agency and resources for selfdetermined, meaningful, sustainable careers. Building upon the Creation Fund, the Development Fund supports the development of new Creation Fund work by providing resources such as time, space, and funding to artists and co-commissioning organizations. The Development Fund:

- provides holistic support for diverse artistic development processes
- increases the quality and life of a work
- expands the capacities for cultural organizations to develop work
- deepens relationships between artists and co-commissioners
- expands relationships with communities

## How funds can be used

Funds can offset a variety of needs when developing a work for public engagement. Guidelines are flexible to meet the unique needs of each project. Funds can be accessed before, during, or after the work's premiere and may support activities including—but not limited to:

- managerial, artistic, and technical costs for the development of the work
- live or virtual developmental or technical residencies
- planning, building, or deepening community engagement before, during, or after the 'presentation' of the work
- relationship building with community organizations, collaborators, cocommissioners, or artists
- writing, reflection, or promotion that helps artists to tell their own stories
- documentation and evaluation
- adapting the work to be presented virtually
- scaling up or down, or reimagining the work
- · fees for artists, technicians, and collaborators and/or staff time

## Who can access the Development Fund?

**NPN** guarantees Development Funds to every Creation Fund project. The Development Fund is artist-led—artists *apply directly* on behalf of each project.

**Artists can access The Development Fund for** *three years* following their Creation Fund Award. Artists will keep receiving Development Fund Application reminders until funds are used.

## **Rolling Deadline**

To accommodate projects' timelines, **the NPN Development Fund has a rolling deadline.** Artists may apply for funds at any time during the creation and development of the work, however, they are only eligible for one Development Fund per Creation Fund project.

## **Award Amount: Two Approaches to Funding**

NPN's approach to artistic support is built on the notion of partnership and long-term relationship building. NPN actively strives to expand the capacities and connectivity of its constituents. The Development Fund is structured to maximize these goals. When

applying for Development Funds, artists may choose between two approaches of support:

- a) Team-based: The artist may apply for co-located funds up to \$10,000 on behalf of the artist and a co-commissioner of the artist's choosing. Funds are split between the co-commissioner and the artist. Recognizing that co-commissioners often contribute much of their own organizational resources—whether these be staff time, rehearsal space, access to designers, or community work—the team-based approach compensates co-commissioners for their contributions. Projects may apply for up to \$5,000 for the artist's developmental needs and up to \$5,000 for the co-commissioner's developmental needs.
- **b) Artist Only**: The artist or company applies for **up to \$5,000** in support. This approach is for artists whose projects do not need additional developmental support from their co-commissioner(s).

It is up to the artist to determine which approach is best for the work. If applying using the team-based approach, artists should select a co-commissioner who will provide resources that best serve the development of the work as needed.

### **Criteria & Limitations**

- Development Fund projects are driven by the artist, not co-commissioners.
- If an artist is applying for funds using the team-based approach, the artist is encouraged to complete the application in collaboration with the cocommissioner. However, the artist should always be the lead and have full agency over the application process.
- Funds can support a variety of artist, technician, and collaborator fees for the
  development of the work. Funds cannot, however, support artists' fees for
  the presentation of a work—fees for the presentation of the work are a
  separate responsibility of the co-commissioners as stated in the Creation
  Fund Letter of Agreement. Funds can be used for work-in-progress showings,
  rehearsals, community development, and additional artistic/technical staff as
  needed.
- Funds can support development activity before, during, or after the first presentation of the work.
- Funds can support activity happening before, during, or after the Development Application, but please try to apply at least 60 days in advance of activities when possible.
- Only projects that have completed the Creation Fund Orientation Call are eligible to apply.

- Creation Fund artists can only access Development Funds once per Creation Fund project.
- Artists can access Development Funds for three years following the Creation Fund award date.
- Matches are not required
- In alignment with NPN's commitment to creating an arts sector rooted in justice, we are committed to ensuring workspaces free of racism, transphobia, homophobia, ableism, misogyny, classism, or other bias. Participants in NPNfunded activity are expected to honor this ethic.

## **Application Tips**

- NPN is flexible and committed to funding projects regardless of timeline shifts that may occur.
- **Keep it clear and simple!** We don't judge applications on grantsmanship, so use plain language and don't feel the need to fill up all the spaces.
- The application should be approached like a plan instead of a competitive application. This is a tool for you to use as you are planning the next phase of your project.
- When completing the plan, focus the request—narrative, timeline, and budget—on the development phase of the project. These funds are meant to build on Creation Funds.
- Review Part 3: Application Guide to plan and gather materials for the online application.
- If working with a co-commissioner using the team-based approach, be sure to
  give yourself enough time to build the project, timeline, and budget together, as
  well as invite the co-commissioner to collaborate on the application through
  NPN's online grantmaking system.
- Applicants may upload a project budget and timeline using the template provided or use their own. If you are applying as a team-based project and using your own project budget and timeline, please differentiate between artists and cocommissioner's activities, costs, and contributions.

## **Selection Criteria**

NPN staff will review applications for fit, using the criteria below. If the application does not fit the following criteria, staff will reach out to artists to reconfigure the project.

- Appropriateness: The project described is supporting the development phase of the work. Funding expands support provided by the Creation Fund. Funding does not cover final presentation costs. Fees paid to artists and/or community collaborators are equitable.
- **Potential Impact:** The project has the potential to deepen relationships, create pathways to new opportunities, or strengthen the overall success of the work.
- **Feasibility:** The artist (and co-commissioners in the case of team-based applications) has the existing relationships and/or a plan to cultivate new relationships, the capacity, and a clear plan (and budget) to carry out the project.



# Tab 5: Co-Commissioner Information (Team-Based Applications Only)

Quick Tip: Please leave time in the process for this step! Do not wait until the day the application is due to invite the co-commissioner.

If you have selected the "Team-based" project approach you will see a tab called "Co-Commissioner Information." A Team-based application cannot be submitted without the Co-Commissioner's input, so please factor that into your submission timeframe. The co-commissioner will be required to create a profile in the system, if they have not done so already.

Press the blue "plus" button to add the Co-Commissioner. When you enter the Co-Commissioner's name, email address and role ("Co-Commissioner DevFund"), you may need to scroll down slightly to see the "Save" and "Invite" buttons. "Invite" the Co-Commissioner and they will get an email to participate in the application. It usually takes a few minutes for the system to send the invitation, so don't worry if they don't get the invitation immediately.
